Artwork Details	
<ul style="list-style-type: none"> • If there is underpainting, the painting must be predominantly soft pastel. • Framed size should not exceed 48 " high by 40 " wide. • Artwork must be attractively framed and wired for hanging. No sawtooth hangers or gallery clips. If mats are used, they must be white or off-white. A slim colored inner mat is acceptable. Paintings with colored mats can be accepted but will be ineligible for awards • <i>Original</i> artwork cannot be more than 3 years old, not done in a class, nor copied from published photos. 	
Shipped Artwork Information	
<ul style="list-style-type: none"> • Must be sturdily framed using plexi-glass.
